Shane is a graduate of the Royal Military College at Duntroon, Australia and served and as an Army Officer in Infantry and Special Forces units for 7 years. Shane then spent 4 years working for a Non-Government Organisation (NGO) and the UN clearing landmines and unexploded ordnance from post-conflict areas including Abkhazia (Georgia), Somalia, Kosovo, Cambodia and Nagorno-Karabakh (Azerbaijan). Shane led the first civilian security logistics operation into Iraq in 2003 days after the conclusion of the conventional war and was the team leader for operational contingency planning for the World Food Programme in Darfur, Sudan. Shane has corporate experience in Crisis and Security Management for the Commonwealth Bank of Australia and is now the Regional Head for Crisis Management for Barclays Capital in Singapore.
