

**GUIDELINES FOR RECERTIFICATION

Schedule II**

Intent: To enable certified personnel to receive the majority of their Recertification credits from their involvement with BCP-related organizations, activities, and training.

- Requirements: CFCP Total of 80 points over a 2-year period.
CBCP Total of 80 points over a 2-year period.
MBCP Total of 80 points over a 2-year period.
CBCA Total of 80 points over a 2-year period.
CBCLA Total of 80 points over a 2-year period.

For CFCPs and CBCPs, two thirds of the points must be earned in activities directly related to business continuity / disaster recovery planning, or GROUP A activities.
